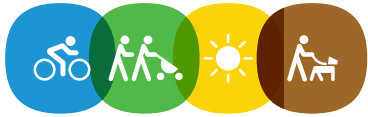

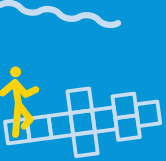

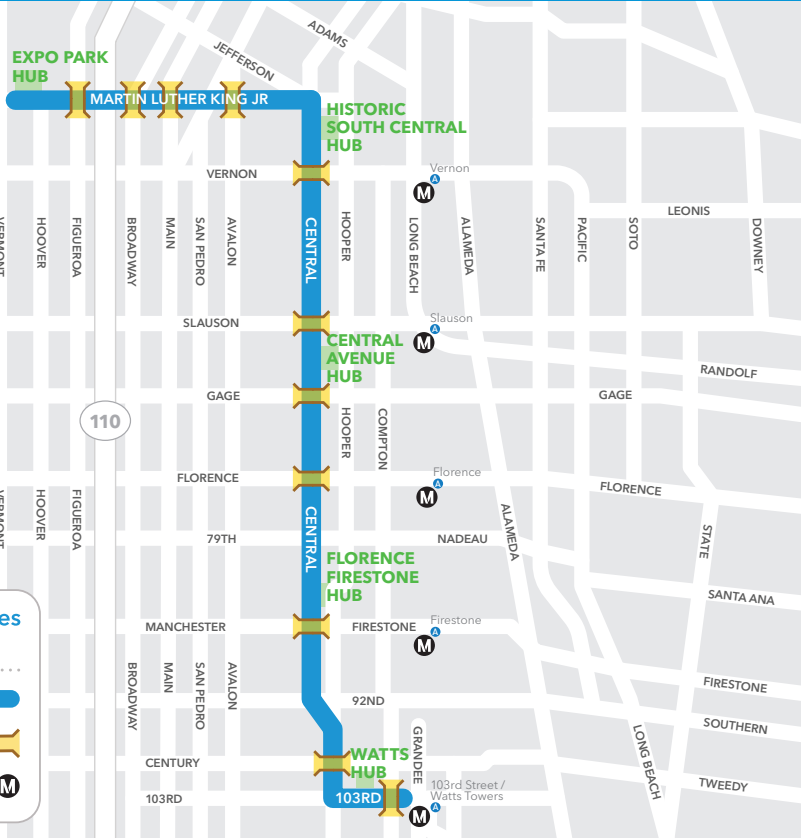

How Will Car Access and Parking be Handled?

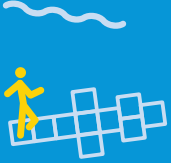
- **ALL DRIVEWAYS ON THE ROUTE WILL BE BLOCKED** from approximately 7am to 5pm on Sunday, December 4. Vehicles will not be allowed to enter or exit the route during this time.
- If your driveway is blocked and you need to use your vehicle on Sunday, December 4, please park elsewhere before 7am that day.
- Street closures begin at 6am, with full route closures in place by 7am. The event runs from 9am to 3pm, and streets will be fully open to cars by approximately 5pm.
- Cars can cross the route at selected major streets (see map). Streets adjacent to the route will remain open to local access for residents and businesses.
- **NO PARKING** allowed on the route after 1am on Sunday, December 4. **Parking restrictions will be posted and towing will be enforced.**
- Additional street parking near the route may be restricted. Please check posted parking restrictions in your neighborhood.
- **Parking reimbursement:** If you live or work directly on the route, CicLAvia **can reimburse** you up to \$20 per vehicle for any parking costs you incur from 8pm on Saturday, December 3 through 5pm on Sunday, December 4. For reimbursement, email a copy of your parking receipt and proof of residence or employment to info@ciclavia.org, SUBJECT: Parking Reimbursement.

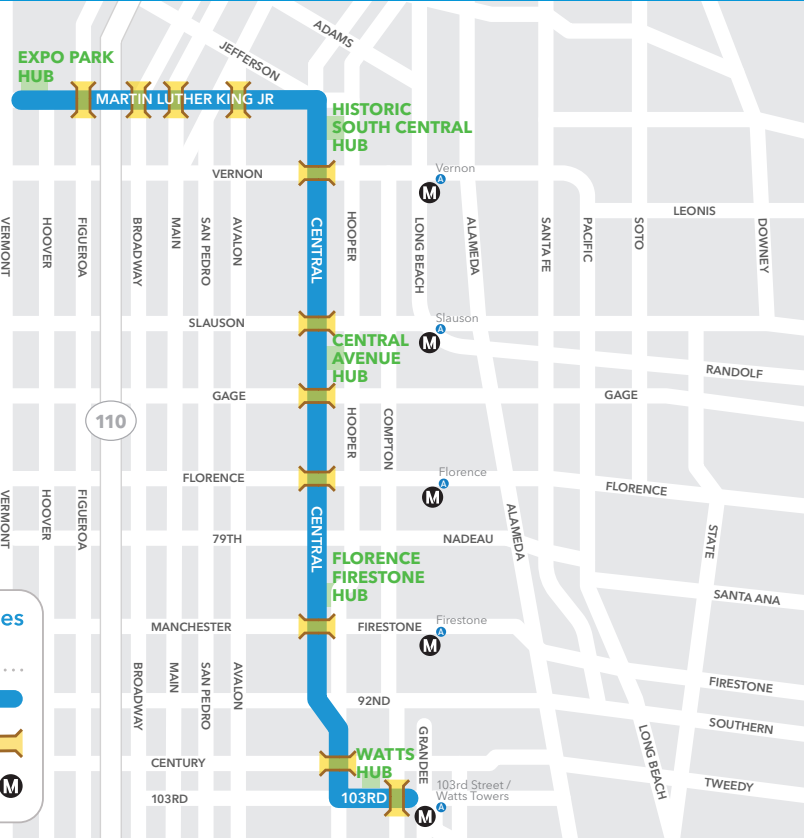

¿Cómo se manejará el acceso de carros y el estacionamiento?

- **TODAS LAS ENTRADAS DE CARROS EN LA RUTA ESTARÁN BLOQUEADAS** desde aproximadamente las 7am a 5pm el domingo 4 de diciembre. Los vehículos no podrán entrar ni salir de la ruta durante este periodo.
- Si su entrada está bloqueada pero usted necesita su carro el domingo 4 de diciembre, favor de estacionar en otra parte antes de las 7am de ese día.
- El cierre de las calles comienza a las 6am, con el cierre completo desde las 7am. El evento es de 9am a 3pm, y las calles estarán abiertas a todas las horas para las 5pm aproximadamente.

Dear Mr. Naipo and Los Angeles Board of Coliseum Commissioners,

As we again approach the fall holidays for this year I am reminded of a situation from last year, specifically Veterans Day, 2021. My neighbor, also a teacher, took her son and a couple of friends with some lunch, to have a seat outside in front of the "Historic Los Angeles Coliseum" right nearby. Upon attempting to enter the front area, seeking view the variety of historic bronzed plaques and memorabilia- they were abruptly told "no, this is private property."

Aside for that incident, regularly witnessing tour buses pulling up and unable to allow eager passengers to access the Coliseum, some have even asked question, as to "when" it will be open and available again(?) The very successful and popular FREE (donations accepted-) Sunday anti aggressive-dog training program has also been forced to "temporarily" relocated to a nearby parking lot, barely adaptable. Other community members and visitors are still unable to enjoy this local historic Los Angeles site, simply due to an "NFL regulated" fence, which was originally constructed for purpose, when hosting the LA RAMS, who have now been gone to SoFi Stadium for approximately two years. The simple question remains: WHEN- will this fence come down?

If I understand the original agreement, contract; this was an NFL requirement, to be removed upon the NFL vacating the site. However, a simple walk, jog, bike ride around the property clearly shows that other construction has continued inside, within those black-tarped large gates, which surround the entire property. The Coliseum should be for the public to enjoy.
